In terms of this authorisation, Kinetic Securities are only providing me with transactional services.
- In all such purchases, sales, or transactions, Kinetic Securities is authorised to follow the instructions of the Investment Advisory Services to which I/we subscribed, and have identified to Kinetic Securities, in every respect concerning the undersigned's account with Kinetic Securities. Kinetic Securities is authorised to act for the undersigned and in the undersigned's behalf, in the same manner and with the same force and effect as the undersigned, with respect to such purchases, sales, or transactions in the account.
